

If You Were Sent a Text Message from US Coachways, Inc., You May Be Entitled to a Payment from a Class Action Settlement

A settlement has been reached in a class action lawsuit claiming that US Coachways, Inc. (“USC”) sent text messages to wireless telephone numbers without consent of the recipients in violation of the Telephone Consumer Protection Act, 47 U.S.C. § 227. USC denies the allegations in the lawsuit, and the Court has not decided who is right.

Who’s Included? You received this postcard because USC’s records show that you may be a member of the Settlement Class. The Settlement includes all persons in the United States who received one or more text messages sent by or on behalf of USC between February 6 and August 7, 2017 reading, in the same or substantially similar language, as follows: “USCOACH: Download USC App \$25OFF Promo ‘uscapp’ <http://usc.am/iPhone> or <http://usc.am/Android>. Text Stop to stop or Help for help. Msg&data rates may apply.”

What Are the Settlement Terms? USC will provide a \$101.03 voucher for USC services to all Settlement Class Members who do not opt out of the settlement. USC has also agreed to pay \$30.31 to Settlement Class Members who submit valid Claims. USC has also agreed to pay attorneys’ fees and costs, and a Service Award to the Class Representative. Only one Claim is allowed per Settlement Class Member.

How Can I Get a Payment? To get a payment, you must submit a Claim Form on the Settlement Website, or by U.S. mail. You may also download or file a Claim Form online at www.DipugliaTCPAsettlement.com or call the Settlement Administrator at the toll-free number below to request a Claim Form. If you send in a Claim Form by regular mail, it must be postmarked on or before **July 30, 2018**. The deadline to file a Claim online is **11:59 p.m. EST on July 30, 2018**.

Your Other Options. If you do not want to be legally bound by the Settlement, you must exclude yourself by **July 30, 2018**. If you do not exclude yourself, you will release any claims you may have, as more fully described in the Settlement Agreement, available at the Settlement Website. You may object to the Settlement by **July 30, 2018**. The Long Form Notice available on the Settlement Website listed below explains how to exclude yourself or object. The Court will hold a Final Approval Hearing on **September 5, 2018** to consider whether to approve the Settlement, a request for attorneys’ fees and costs in an amount not to exceed \$494,000, and a Service Award of \$5,000 to the Class Representative. You may appear at the hearing, either yourself or through an attorney you hire, but you don’t have to. For more information, call or visit the Settlement Website. U4361 v.03
